### **Notice Concerning Debt Financing (Determination of Interest Rates)**

MID REIT, Inc. (hereafter "MID REIT") announces today the finalized interest rates, as outlined below, for the borrowings announced on August 22, 2008 ("Term Loans").

1. Long-term debt (Term Loan) (2 years contracts)

3. In accordance with the interest-rate swap agreement with the notional amount of ¥3.5 billion, the actual interest rate for said amount is 1.57% (p.a.) up to the repayment date. Interest rates after May 30, 2009 will be announced when they are determined.
