Notice Concerning Obtainment of "Building-Housing Energy-efficiency Labeling System (BELS)" Certification

MCUBS MidCity Investment Corporation (hereafter "MCUBS MidCity") announces that it has received "Building-Housing Energy-efficiency Labeling System (BELS)" certification for three properties for the first time. The details are as follows.

1. Overview of the BELS

BELS certification, established on April 2014 by the Ministry of Land, Infrastructure, Transport and Tourism, is provided under a public evaluation system, which evaluates the energy conservation performance of non-residential buildings. Third parties evaluate the performance of buildings from various points of view, regardless of whether a building is new or not, and the evaluation result is represented by a number of stars (from one " \star " to five stars " $\star \star \star \star \star$ ").

BELS certification, which is the first public evaluation system specific to energy conservation performance in Japan, is expected to promote further improvements in providing appropriate information as well as of the energy conservation performance of buildings.
