Notice Concerning Obtainment of Tokyo Low-Carbon Small and Medium-Sized Model Building, CASBEE and BELS Certification

1. Tokyo Low-Carbon Small and Medium-Sized Model Building

(1) Overview

Tokyo Low-Carbon Small and Medium-Sized Model Building is A1 or higher ranked building based on an assessment index for low-carbon buildings (low-carbon building benchmark) announced by the Tokyo Metropolitan Government in May 2012, with an aim to create the real estate market in which low-carbon buildings featuring low CO2 emission are valued.

MCUBS MidCity received Tokyo Low-Carbon Small and Medium-Sized Model Building notifications for the first time for two of its properties.

2. Certification for CASBEE for Real Estate

(1) Overview

Certification for CASBEE for Real Estate is an evaluation system that evaluates and ranks buildings and structures in terms of their environmental performance by using CASBEE (Comprehensive Assessment System for Built Environment Efficiency). In addition to each building's ability to reduce its environmental impact across a variety of areas including energy and resource conservation as well as recycling, this system comprehensively evaluates the environmental performance of each building and structure including its aesthetic appeal.

MCUBS MidCity acquired new Certification for CASBEE for Real Estate for two of its properties (including recertification) in addition to two properties already acquired.

3. BELS Certification

(1) Overview

BELS (Building-Housing Energy-efficiency Labeling System), established on April 2014 by the Misintry of Land, Infrastructure, Transport and Torism, is provided under a public evaluation system, which evaluates the energy conservation performance of non-residential buildings. Third parties evaluate the performance of buildings from various points of view, regardless of whether a building is new or not, and the evaluation result is represented by a number of stars (from one " \star " to five stars " $\star \star \star \star \star$ ").

MCUBS MidCity acquired new BELS certification for two properties in addition to three properties already acquired.
